## **Definition of personal property**

The following constitutes personal property:

- household effects such as personal effects, household linen, furnishings and equipment
- cycles and motor cycles private motor vehicles and their trailers, camping caravans, pleasure craft and private aeroplanes
- household provisions appropriate to normal family requirements
- household pets and saddle animals

• portable instruments of the applied or liberal arts, required by the person concerned for the pursuit of his trade or profession.

No relief is granted for alcoholic products, tobacco and tobacco products or commercial means of transport and articles for use in the exercise of a trade or profession other than portable instruments of the applied or liberal arts.

Personal property must not be such as might indicate, by its nature or quantity, that it is being imported for commercial reasons.
